



## MANUAL TRAINING CURRICULUM

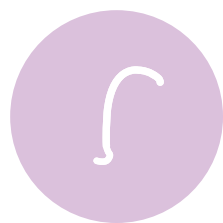
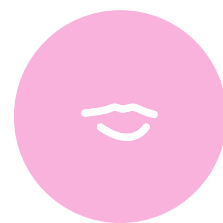
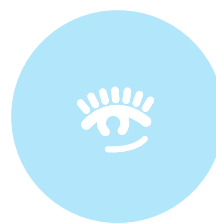
